Tribal Access to Confidential Juvenile Court Files: The Judicial Council will consider the proposal to amend section 827 of the Welfare and Institutions Code. It is on the consent agenda for December 13, 2013. http://www.courts.ca.gov/documents/jc-20131213-itemG.pdf

Uniform Adult Guardianship and Protective Proceedings Jurisdiction Act (UAGPPJA) proposed for California: Submitted comments on tentative recommendation of the California Law Revision Commission for adoption in California of a modified version of the Uniform Adult Guardianship and Protective Proceedings Jurisdiction Act to address issues involving conservatorships for members of Indian tribes located California. These comments included a new Article 6 be added to the proposed California UAGPPJA, consisting of new Probate Code sections 2041–2047, to deal specifically with interactions between California tribal courts and state courts in matters covered by UAGPPJA. The Commission has agreed to amend its recommendation to incorporate comments. This webinar will enable tribes (tribal leaders/tribal professionals/tribal attorneys) to evaluate the pros and cons of implementation of various aspects of the Tribal Law and Order Act (TLOA), including enhanced sentencing. The analysis will include a method to determine the pros and cons for each particular tribe; what general considerations the tribe may take into account including which crimes to pursue enhanced sentencing for; what, if any, additional costs the tribe may encounter and how to limit those additional costs; what portions of TLOA the tribe may wish to take advantage of if it chooses to implement enhanced sentencing; and/or other aspects of TLOA that may affect the tribe. Research on the Health Determinants and Consequences of Violence and its Prevention, Particularly Firearm Violence

Due By: January 5, 2014

This funding opportunity announcement (FOA) spans across the missions of several NIH Institutes and Centers (ICs) and Offices, and includes basic neuroscience and basic behavioral research, clinical and translational studies, intervention development at the individual, family and community level, efficacy trials of interventions based on evidence from basic and translational studies, and research to identify the best ways to disseminate and implement efficacious and evidence-based interventions in real-world settings. While this FOA covers all of the areas mentioned above, particular consideration will be given to applications that propose studies of the intersection that focus on the various types of violence (homicide, suicide, youth and gang-related, intimate partner) and firearms.

Behavioral & Integrative Treatment Development Program (R03) Due By: January 7, 2014

The purpose of this FOA for R03s is to encourage investigators to propose discrete well-defined projects that can be completed within two years. Projects of interest fall within the research domain of behavioral or integrated (e.g., behavioral and pharmacological) interventions targeting: (a) drug abuse (including comorbidities); (b) prevention of acquisition or transmission of HIV infection among individuals in drug abuse treatment; (c) promotion of adherence to drug abuse treatment, HIV and addiction medications; and (d) chronic pain. Specific examples include, but are not limited to studies

focusing on: 1) Stage I intervention generation; 2) Stage I pilot or feasibility – and both should include the development of putative moderators, mediators, and change mechanisms; (3) Stage I studies to generate or refine drug abuse treatment or adherence interventions for use in primary care; (4) Stage I research to boost effects and increase implementability of interventions with creative use of technology or through other means.

Translational Research to Improve Diabetes and Obesity Outcomes (R01) Due By: January 7, 2014

This Funding Opportunity Announcement (FOA) encourages NIH Research Project Grants (R01) to test practical, sustainable, and cost efficient adaptations of efficacious strategies or approaches to prevent and treat diabetes and/or obesity. Research focused on the prevention or reversal of obesity, prevention of type 2 diabetes, improved care of type 1 and type 2 diabetes, or the prevention or delay of the complications of these conditions is encouraged. The approaches tested should have the potential for wide dissemination and implementation outside of an academic setting such as in routine clinical practice or communities at risk.

AmeriCorps State and National Grant Competitions Corporation for National and Community Service

Transitional Living Program and Maternity Group Homes Due By: January 15, 2014

The Family and Youth Services Bureau (FYSB) through the Transitional Living Program (TLP) and for Maternity Group Homes (MGH) provide an alternative to involving RHY in the law enforcement, child welfare, mental health, and juvenile justice systems. Each TLP must provide a safe and appropriate shelter for up to 21 months of services with adult supervision, life and interpersonal skill building, career counseling and job skills, counseling, and medical care as appropriate. MGHs provide the same services as a TLP in addition to providing parenting instructions and child care. Other services that are offered include, but are not limited to, transportation, family planning, abstinence education and pregnancy prevention services.

Healthy Start Initiative: Eliminating Disparities in Perinatal Health Health Resources & Services Administration — Department of Health and Human Services Due By: January 17, 2014

This announcement solicits applications for the Healthy Start Initiative: Eliminating Disparities in Perinatal Health program. The Healthy Start (HS) program aims to reduce disparities in infant mortality and adverse perinatal outcomes by: 1) improving women¿s health, 2) promoting quality services, 3) strengthening family resilience, 4) achieving collective impact, and 5) increasing accountability through quality improvement, performance monitoring, and evaluation. HS grants are provided to communities with rates of infant mortality at least 1½ times the U.S. national average and high rates for other adverse perinatal outcomes (e.g., low birthweight, preterm birth, maternal morbidity and mortality) in order to address the needs of high-risk women and their families before, during, and after pregnancy. HS works to reduce ¿the disparity in health status between the general population and individuals who are members of racial or ethnic minority groups. ¿ 42 U.S.C. § 254 c-8(e)(2)(B). Behavioral and Social Genomics of Aging: Opportunities in the Health and Retirement Study Due by: September 7, 2014

The Health and Retirement Study (HRS) is a longitudinal, nationally representative sample of the US population aged 50 years and older (plus spouses) with an oversample of African and Hispanic Americans and a total sample size of over 20,000). Using funds from the American Reinvestment and Recovery Act, the HRS is currently conducting genome-wide scans of DNA samples from approximately 20,000 participants, using the Illumina HumanOmni 2.5 Quad chip. It is anticipated that the genotype data for the first 13,000 subjects will be released to the public via dbGaP in the Fall of 2011, with data from the remaining participants to be released by the end of 2012. This FOA encourages applications taking advantage of the newly available genetic data to advance our understanding of how genetic, behavioral, and psychosocial factors

Indian Community Development Block Grant (ICDBG) Program Due by: Not specified

The ICDBG Program provides eligible grantees with direct grants for use in developing viable Indian and Alaska Native Communities, including decent housing, a suitable living environment, and economic opportunities, primarily for low and moderate income persons. The ICDBG program can provide funding for recipients in the following categories: *Housing:* Housing rehabilitation, land acquisition to support new housing construction, and under limited circumstances, new housing construction. *Community Facilities:* Infrastructure construction, e.g., roads, water and sewer facilities; and, single or multipurpose community buildings. *Economic Development:* Wide variety of commercial, industrial, agricultural projects which may be recipient owned and operated or which may be owned and/or operated by a third party.

Recovery Act - American Recovery and Reinvestment Act (ARRA): Tribal Transit Program Due by: "to be determined"

The Federal Transit Administration (FTA) will be accepting discretionary applications for funds made available under the "American Recovery and Reinvestment Act, 2009" (Pub. L. 111-5; "ARRA") to the Public Transportation on Indian Reservations Program (Tribal Transit Program). The ARRA was signed into law by President Barack Obama on February 17, 2009. Goals of the statute include the preservation and creation of jobs and promotion of an economic recovery, as well as the investment in transportation, environmental protection, and other infrastructure providing long-term economic benefits. The ARRA, Tribal Transit program purpose is to provide funding to federally recognized Indian Tribes for public transportation capital projects for use in public transportation. Under ARRA, \$17 million is available for discretionary award.
