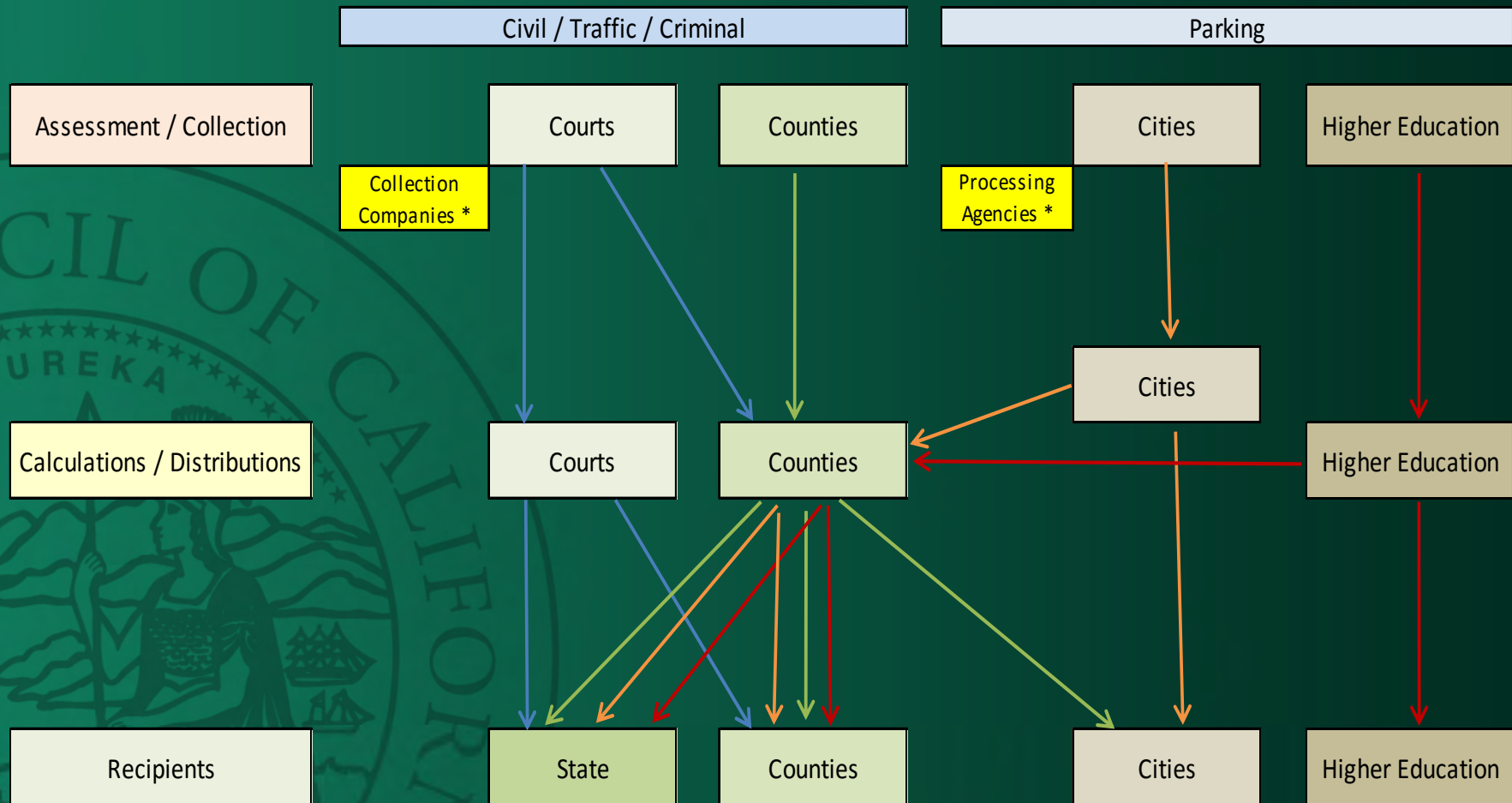

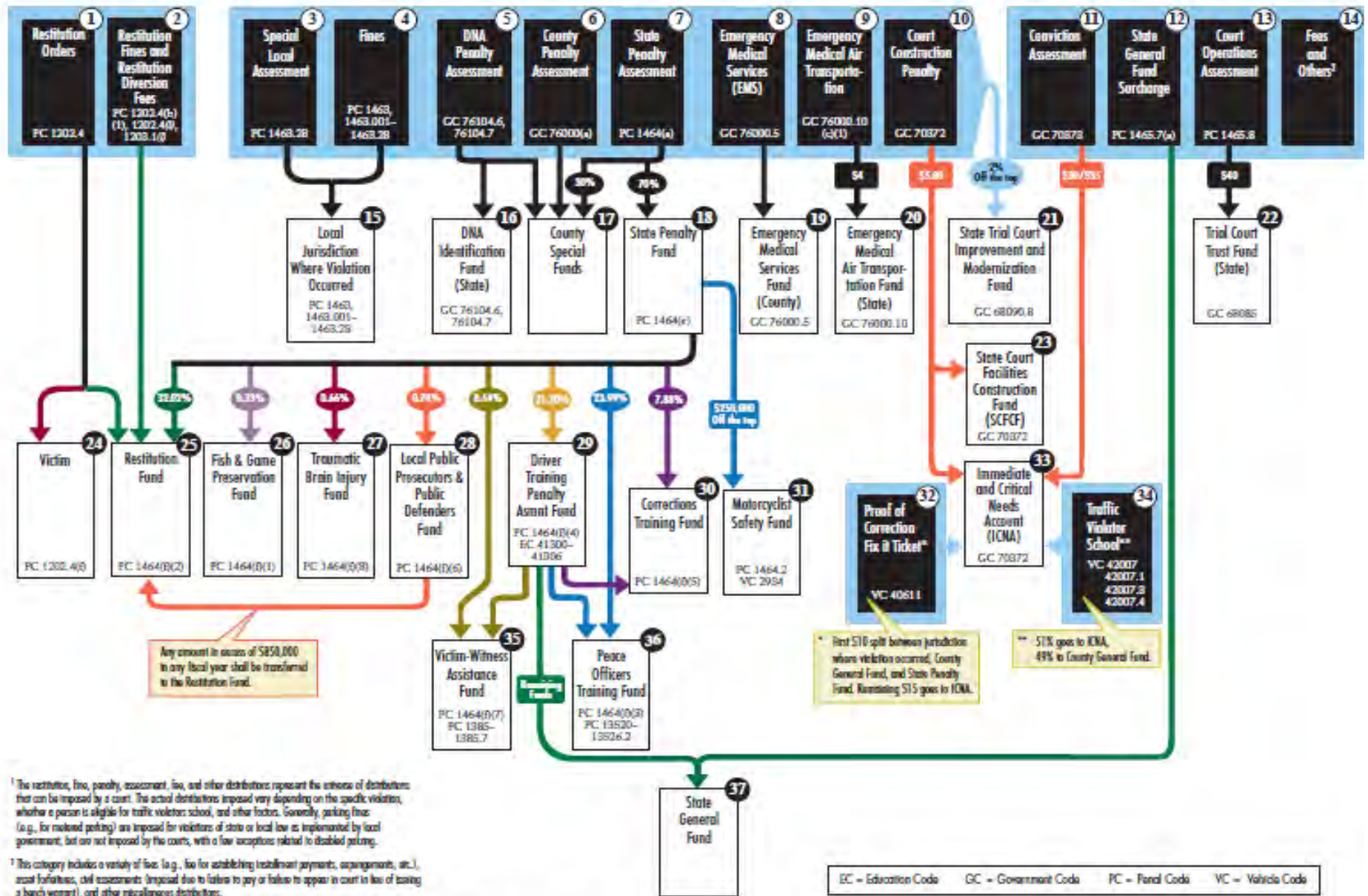

Distribution of Criminal/Traffic Fines, Penalties, and Fees¹



¹ The restitution, fine, penalty, assessment, fee, and other distributions represent the universe of distributions that can be imposed by a court. The actual distributions imposed vary depending on the specific violation, whether a person is eligible for traffic violator school, and other factors. Generally, parking fines (e.g., for no-load parking) are imposed for violators of state or local law as implemented by local government, but are not imposed by the courts, with a few exceptions related to disabled parking.

² This category includes a variety of fees (e.g., fee for establishing installment payments, assignments, etc.), asset forfeitures, civil assessments (imposed due to failure to pay or failure to appear in court in lieu of posting a bench warrant), and other miscellaneous distributions.

UNIFORM BAIL AND PENALTY SCHEDULES (UBPS)

Every year the Judicial Council is required* to establish a mandatory penalty schedule for:

- traffic infractions

The UBPS also includes suggested base fines for the following schedules:

- boating
- forestry
- fish and game
- public utilities
- parks and recreation
- business licensing

THE UBPS TRAFFIC INFRACTION SCHEDULE

Unless otherwise specified traffic violations default to the infraction category. Therefore, the vast majority of the annual revisions to the UBPS are to the traffic infraction schedule.

The Council has classified traffic infractions into four penalty categories, according to the severity of offenses, to allow convenient notice and payment of the scheduled penalty.

Infraction Category	Severity of Offense	Base Fine
1	Bicyclist, motorized scooter, pedestrian, pocket bike, vehicle registration and equipment offenses	\$25
2	Driver's license, operation of vehicle, and size and load offenses	\$35
3	Substance abuse infractions, VC 2818 (trespassing electronic beacon), VC 20004 (reporting deaths), VC 21706.5 (operation of vehicle in emergency accident zone), VC 27375 (modified limousines)	\$70
4	Miscellaneous offenses for which the penalties or the fee for dismissal with proof of correction are specifically set by the Vehicle Code, speeding offenses (refer to Speed Chart), and infractions pursuant to PC 19.8	\$25

Certain offenses are eligible for correction and, if the defendant signs the citation signifying his or her promise to correct, only require payment of a \$25 court processing fee.



COUNTYWIDE BAIL SCHEDULES

The Council is not the only entity required to publish a bail schedule. Each individual court is required to prepare, adopt and annually revise a uniform countywide schedule of bail for all bailable felony offenses and for all misdemeanor and infraction offenses, except Vehicle Code infractions. Thus, while the Council is required to publish the traffic infraction schedule, the counties are responsible for all of the others.

Rule 4.102 additionally requires that, when performing those duties, counties “give consideration to the (UBPS) approved by the Judicial Council.” After adopting their countywide bail schedule, courts must send a copy of their countywide schedule to the Council “with a report stating how the revised schedule differs from the (UBPS).”



UBPS AS A GUIDE

Although the UBPS began as a penalty schedule for traffic offenses, over time the Council adopted additional schedules under the rule, including boating, forestry, fish and game, public utilities, parks and recreation, and business licensing.

The amounts listed in the non-traffic schedules serve as guidelines for the courts' countywide schedules. The rule requirement that the UBPS provide this guidance to the counties for non-traffic schedules is the reason that, on an annual bases, this committee revises those schedules based upon changes in law during the preceding year.

- F. "Total Bail" shall not exceed statutory limits. Vehicle Code section 40310 specifies that the "fine" amount of the total bail shall not exceed the limitations specified by Vehicle Code sections 42001 and 42001.5.
- G. Rule 4.105 of the California Rules of Court provides that with certain exceptions deposit of bail is not required to appear for arraignment or trial for an infraction case. Deposit may be required: by statute, such as trial by written declaration; if a person does not sign a promise to appear as ordered by the court; or a judicial officer states a reason for a deposit to schedule a trial.

In cases where a court appearance is required by a court, the amounts set forth in the Uniform Bail and Penalty Schedules do not necessarily indicate the appropriate total penalties; rather, they ensure that, in most cases, when bail is posted, sufficient funds will be available to meet the defendant's obligations. Upon conviction, however, "additional penalties" are added to any fine. It is incumbent upon the judge who hears each case to determine the proper total penalty (fine and "additional penalties") based on the particular facts presented.

With the exception of juveniles under age 18, there shall be no mandatory court appearance for any infraction of the California Vehicle Code punishable by fine only. A court may require a mandatory appearance for an infraction violation of the Vehicle Code when a statutory driver's license restriction, suspension, or revocation is authorized; community service or proof of payment or correction is mandatory; or a violation requires specific action under the Vehicle Code in addition to a fine. This paragraph does not apply to violations of local ordinances based on Vehicle Code sections.

- H. The "Total Bail" for an offense *not specifically listed* in the Uniform Traffic Infraction Bail and Penalty Schedule is the amount set for the general category of that offense unless a California code or regulation specifies otherwise. The court operations assessment and criminal conviction assessment are collected in addition to the "Total Bail." The suggested minimum "Total Bail" for an offense *not specifically listed* in the Uniform Traffic Misdemeanor Bail and Penalty Schedule, unless a California code or regulation specifies otherwise, is:

	Base	+ Additional Penalties*&	Surcharge	+	Fees	= Total Bail*/Fees (*See sections II-IV)
Misdemeanor	\$ 75	+	\$251	+	\$70	= \$396
Infraction	\$ 35	+	\$127	+	\$75	= \$237

The suggested minimum "Total Bail" for an offense *not specifically listed* in the Uniform Public Utilities Bail and Penalty Schedule, unless a California code or regulation specifies otherwise, is:

Court-Ordered Debt Program

Background and Funding

- In 1994, the State Legislature authorized the FTB to collect delinquent court-ordered debt as a pilot program.
- In 2004, the Legislature made the program permanent and expanded it statewide. (California Revenue and Taxation Code Sections 19280–19282).
- Funding is provided by the participating courts and agencies. These costs cannot exceed 15 percent of the amount COD collects on behalf of their clients.

Court-Ordered Debt Program

Program Eligibility and Enrollment

Eligibility

- State Agencies:
 - Any type of restitution orders and fines imposed by Juvenile or Superior Court of the State of California.
- Courts:
 - Any type of fines, state or local penalties, bail and forfeitures.
 - All offenses involving a violation of the Vehicle Code, and any amounts due pursuant to Section 903.1 of the Welfare and Institutions Code.

Enrollment

- Memorandum of Understanding
- Onboarding
- Testing

Court-Ordered Debt Program

Debt Criteria

The following criteria must be met when submitting cases:

- Your case should be 90 days or more delinquent
- Minimum case balance must be \$25.00
- Minimum account balance due of \$100.00
- Must include your debtor's first and last name
- Must have either a social security number, date of birth, or drivers license number
- Addresses must be complete

Court-Ordered Debt Program


How the Program Works

- Validate Information
- Create a COD account
- Begin the collection cycle
 - Demand Notice
 - Wage Garnishment
 - Bank Levy

- We will return the case if:
 - We are unable to locate a good SSN
 - Case is deemed uncollectable

Background

- Began in 1975.
- Authorized by Govt. Code Sections 12419.2-3, 12419.5, 12419.7-12.
- Administered by FTB on behalf of the State Controller's Office (SCO).

- Types of intercepted payments:
 - Personal Income Tax Refunds
 - Lottery Winnings
 - Unclaimed Property Disbursements

In 2016, the program redirected 960,590 payments valued at over \$324 million dollars.

Intercept Program

Program Eligibility

- State agencies
Any type of debt.
- Courts, Counties and cities
Property taxes, delinquent fines, bails, and other permitted debts.
- California colleges
Delinquent registration, tuition, bad check fees, and other permitted debts.
- Special districts
Water bills, waste disposal fees, and fire inspection fees.

Intercept Program

How the Program Works

- Participating agencies submit debtor accounts via Secure Web Internet File Transfer. Submit debts where:
 - Debt type qualifies under the Intercept Program authority.
 - 30 days have passed since the Pre-Intercept Notice has been mailed.
 - Debt amount is at least \$10.
 - Debtor is not in an active bankruptcy.
 - Debtor has a valid social security number.
 - There is one sum total debt amount for each debtor.
- We flag accounts with an offset indicator.
- We reject debtor accounts that do not meet our criteria.

Intercept Program

How the Program Works

- IIC notifies you when offset occurs.
- IIC sends the debtor an Intercept Notice with:
 - Debtor's account number with the agency
 - Original payment amount
 - Offset amount
 - Remaining refund amount
 - Agency's public contact address and telephone number
 - Government code authorizing the Intercept Program

- Address or telephone number for your agency.

Yearly Timeline

September

- Submit all forms.
- Mail all pre-notices.

November

- Submit the annual load file to FTB.

December

- Intercept purges all current year accounts mid month.
- Intercept loads all new annual accounts by end of month.

May

- SCO bills all participants for prior year services.

SCO charges a fee to reimburse the administrative costs of the program.

- Fee based on actual costs incurred
- Varies each year
- Approximately \$2 per offset

- Bills sent in April/May for each successful offset we collect during the previous calendar year.

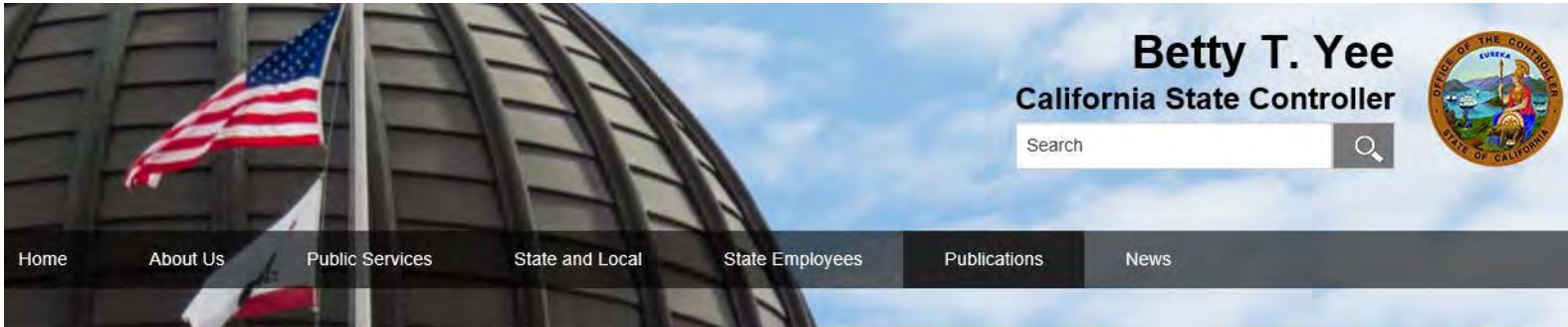

The **Trial Court Revenue Distribution Guidelines** provide direction on the distribution of fees, fines, forfeitures, penalties, and assessments resulting from criminal and civil violations.
(*Government Code §71380*)

Types of Trial Court Revenues

- **Fees** – a sum paid or charged for a service
- **Fines** – a sum imposed as punishment
- **Forfeitures** – the loss of property or money through seizure
- **Penalties/Assessments** – a sum imposed as punishment in addition to a fine



Fines, Penalties, and Assessments

Base fines are typically increased by the following:

State Penalty: \$10 for every \$10*

Local Penalty: Up to \$7 for every \$10*

EMS Additional Penalty: \$2 for every \$10*

State & Local DNA Penalties: \$5 for every \$10*

State Court Facilities Construction Penalty: \$5 for every \$10*

**(or portion thereof)*

Or, up to **\$29 for every \$10** in base fine (or portion thereof) is added, plus **State Surcharge** (20% of the base fine).

These penalties apply to all criminal fines unless otherwise specified, and do not include all possible assessments.



Distribution of Trial Court Revenues

[PC §1463.001](#) tells how the collected fines, penalties, service charges, and allocations are distributed each month:

1. Penalties and assessments added to base fines are distributed to the proper funds, according to law.
2. Unless specified, base fines are distributed as follows:
 - **County arrests** are distributed 100% to **county**.
 - **City arrests** are split between **city and county** pursuant to [PC §1463.002](#).
3. Base fines **with** a specified distribution are allocated to the proper funds, as described in the Guidelines.

TITLE 8. THE ORGANIZATION AND GOVERNMENT OF COURTS [68070 - 77655] (Title 8 added by Stats. 1953, Ch. 206.)

CHAPTER 1. General Provisions [68070 - 68114.10] (Chapter 1 added by Stats. 1953, Ch. 206.)

68090.8. (a) (1) The Legislature finds that the management of civil and criminal cases, including traffic cases, and the accounting for funds in the trial courts requires these courts to implement appropriate levels of administrative automation.

(2) The purpose of this section is to make a fund available for the development of automated administrative systems, including automated accounting, automated data collection through case management systems, and automated case-processing systems for the trial courts, together with funds to train operating personnel, and for the maintenance and enhancement of the systems. As used in this paragraph, "automated administrative systems" does not include electronic reporting systems for use in a courtroom.

(3) Automated data collection shall provide the foundation for planning, research, and evaluation programs that are generated from within and outside of the judicial branch. This system shall be a resource to the courts, the Judicial Council and its committees, the Administrative Office of the Courts, the Legislature, the Governor, and the public. During the developmental stage and prior to the implementation of the system, the Legislature shall make recommendations to the Judicial Council as to the breadth and level of detail of the data to be collected.

(b) Prior to making any other required distribution, the county treasurer shall transmit 2 percent of all fines, penalties, and forfeitures collected in criminal cases, including, but not limited to, moneys collected pursuant to Chapter 12 (commencing with Section 76000) of Title 8 of this code, Section 13003 of the Fish and Game Code, Section 11502 of the Health and Safety Code, and Chapter 1 (commencing with Section 1427) of Title 11 of Part 2 of the Penal Code, into the State Trial Court Improvement and Modernization Fund established pursuant to Section 77209, to be used exclusively to pay the costs of automated systems for the trial courts, as described in paragraph (2) of subdivision (a). These systems shall meet Judicial Council performance standards, including production of reports as needed by the state, the counties, and local governmental entities.

Reading Entries in the Guidelines

1. **Code Section** – The law involved, along with a description.
2. **Violation/Situation** – The laws being violated, or the circumstances in which the revenue is to be paid.
3. **Distribution** – Which agencies receive the revenue, and the percentages and/or conditions that apply.
4. **Applicable Fund** – The fund receiving the revenue.
5. **Fund Use/Special Provision** – Any limitations on use of the collected funds.
6. **Priority of Installment Payments** – The priority given to paying this charge according to Penal Code §1203.1d *(for criminal cases only)*.

BUSINESS AND PROFESSIONS CODE

CHAPTER 2.3. Online Child Care Job Posting Services [18890 - 18890.6]

18890.4. (a) An **online child care job posting service** or **background check service provider** that **fails to comply with** the requirements of **this chapter** may be liable for a **civil penalty of one thousand dollars (\$1,000) for each offense**. The Attorney General, a city attorney, or a county counsel may bring an action to impose a civil penalty pursuant to this section after doing both of the following:

(1) Providing the online job posting service or background check service provider with reasonable notice of noncompliance. The notice shall inform the online job posting service or background check service provider that it will be subject to a civil penalty if it does not correct the violation within 30 days from the date the notice is sent to the online job posting service or background check service provider.

(2) Verifying that the violation was not corrected within the 30-day period described in paragraph (1).

(b) The civil penalty shall be deposited into the **General Fund if the action is brought by the Attorney General**. If the action is brought by a **city attorney, the civil penalty shall be paid to the treasurer of the city** in which the judgment is entered. If the action is brought by a **county counsel, the civil penalty shall be paid to the treasurer of the county** in which the judgment is entered.

EMAT Penalties

EMAT penalties are being incorrectly distributed in Red Light Violations & Traffic Violator School (TVS) Violations

Red Light Violations

- PC §1463.11 requires certain revenues collected for red light violations to be allocated:
 - **First 30% of PC §1463.001 base fine, PC §1464 state penalty, GC §70372(a) state court construction fund, GC §76000 local additional penalties, and GC §76000.10 EMAT goes to the city/county general fund.**
 - **Remaining 70%** (after deducting 2% automation) is deposited by the county treasurer under PC §1463 and 1464 on a pro rata basis.
- EMAT Penalty (GC §76000.10) should be included in the 30% allocation.

TVS Violations

- When the defendant elects to take traffic school, the total bail is converted into a TVS fee. (VC §42007)
- EMAT penalty (GC §76000.10) is **not an exception** to VC §42007 and should still be included in TVS fee.
- Leads to findings in the TVS portion of the 50-50 Excess of Qualified Revenues.

Distribution of Parking Surcharges and Penalties

Parking surcharges and penalties are not being distributed as required

Parking Surcharges and Penalties:

- VC §40200.4 requires processing agencies to deposit with county treasurer all sums due to the county from parking violations.

County Criminal Justice Facilities Fund	GC §76000	\$1.50
County Court Construction Fund	GC §76000	\$1.50 (or \$0 depending on BOS resolution)
County General Fund	GC §76000	\$2.00 (\$1.00 from CJFF & \$1.00 from CCF or entire \$2.00 from CJFF)
State Court Construction Facilities Fund	GC §70372(b)	\$1.50
State Court Construction Facilities Fund ICNA	GC §70372(b)	\$3.00
State Trial Court Trust Fund	GC §76000.3	\$3.00

- These parking surcharges and penalties are not being imposed and collected from some of the parking citation issuing agencies such as universities, colleges, and cities.
- These parking surcharges and penalties are not being remitted or incorrectly distributed (should be \$12.50 or \$11.00 per case) by the issuing agencies.
- The entire amount of \$2 per parking violation are not being deposited into county General Fund GC §76000(c). This leads to incorrect calculation of 50-50 Excess of Qualified Revenues.

Equipment/Tag Violations

Qualified penalties not being distributed to the State

- **VC §40225(d)** allows equipment and registration tag violations entered on notices of parking violations to be processed as civil penalties.
- This is **NOT** distributed like the additional parking penalties. Equipment/Tag violations use any penalty collected (including late penalties) divided equally between the State Treasury and issuing/processing agency.
 - Fix – it tickets which penalties are reduced to \$10 are also included in the 50-50 split between the state treasury and issuing/processing agency.

50-50 Excess of Qualified Revenues

Underremittances to the State, due to incorrect calculation of total collections of qualified revenues

Calculate the revenue the county general fund has received from the eight specified fines, fees, and forfeitures stated in GC §77205; compare that amount to the statutory threshold listed in GC §77201.1; and remit 50% of the difference to State Trial Court Improvement and Modernization Fund and 50% to the County General Fund.

QUALIFIED REVENUE IN GC §77205	AMOUNT TO BE CALCULATED INTO MOE PAYMENTS
PC §1463.001 Base Fines	For county arrests, 75% of base fines and forfeitures (other than parking and H&S base fine). For city arrests, 75% of base fines and forfeitures (other than parking and H&S base fine) from the county percentage as listed in PC §1463.002.
PC §1464 - State Penalty	30% of county share of the state penalty deposited into the County General Fund.
VC §42007 - Traffic Violator School (TVS) Fee	77% of TVS fee collections deposited into the County General Fund.
VC §42007.1 – Traffic Violator School (TVS) Fee	\$24 TVS fee deposited to the County General Fund.
GC §27361(b) - Recording and Indexing Fee	100% of collections of the \$1 fee pursuant to GC §27361(b) deposited to the County General Fund.
PC §1463.07 - Administrative Screening and Citation Processing fee *Formerly GC §29550(f)	100% of collections deposited to the County General Fund.
GC §76000(c) – County General Fund portion of county parking penalty	100% of collections of the \$2 portion of every parking fee deposited to the County General Fund.

50-50 Excess of Qualified Revenues

Underremittances to the State, due to incorrect calculation of total collections of qualified revenues

VC §42007 – Traffic Violator School Fee

- **Only 77% of the TVS Fee** to the County General Fund (CGF) shall be calculated into the MOE (Maintenance of Effort) limit before 50-50 split.
- Counties have been issued findings for **excluding EMAT penalties from TVS fee**, resulting in an underremittances of excess qualified revenues.

GC §76000(c) – County General Fund portion of parking penalties

- The \$2.00 are to be calculated into the GC §76000 total collections of the MOE before 50-50 split.
- Counties have received multiple findings for not distributing parking penalties, resulting in an underremittances of excess qualified revenues.

Tips to help prepare for an audit

- Cash Statements
- Maintenance of Effort
- Parking
- Testing
- BOS resolutions
- Prior Audit Findings
- TC-31s

Cash Statements and MOE

- Identify all the different revenues on the cash statements (city, county, state).
- Make sure the cash statements include ALL the revenues and adjustments (not just cash).
- Monthly reconciliation between the cash statements and TC-31s.
- Be able to identify what funds make up the total qualified amounts for the MOE calculation.

Parking

- Have contact information of all parking agencies.
- Inform the parking agencies about the audit.
- Make sure parking entities include breakdown distribution information for each check amount.
- Keep a list of entities that are not remitting parking revenues to the County.

Additional Tips

- Verify your distributions using the Judicial Council distribution testing templates.
- Keep applicable Board of Supervisor resolutions handy.
- Keep records of corrective actions for prior audit findings- even the non monetary ones.
- Notify the State Accounting and Reporting Division to receive electronic stamped copies of TC-31s.

Judicial Council Audit Services:

- Audits superior courts, including review of revenue distribution calculations and distributions
- Revenue distribution review is on current calculations and distributions to provide suggestions for improvements going forward
- Cannot review all distributions, so focus is on high-volume case types, such as speeding, and some common and complex distribution case types, such as traffic school

Systemic revenue distribution issues found on **past audits:**

- Board of supervisor (BOS) resolutions
 - Imposed and distributed GC 76000 local penalties that are not supported by county BOS resolutions
- Traffic school distributions
 - Transferred the GC 68090.8 2% State Automation amount from the fine and penalty components of the TVS fee
- Emergency Medical Air Transportation (EMAT) penalty
 - Distributed EMAT penalty to State instead of including as part of TVS fee on traffic school cases (exception is child seat traffic school cases)



Systemic revenue distribution issues found on **past audits**:

- 30% Red Light (RL) and Railroad (RR) allocations
 - Did not calculate the 30% allocation from the base fine and applicable penalties for PC 1463.11 RL and PC 1463.12 RR bail forfeiture cases (new CMS configuration issue)
- Fishing without a license
 - Did not assess the FG 12021 \$15 State Secret Witness penalty for fishing without a license cases



Systemic revenue distribution issues found on **past audits**:

- Other issues
 - Imposed the VC 40508.6(a) \$10 DMV Administrative assessment on the initial conviction of a Vehicle Code violation instead of for a subsequent Vehicle Code violation.
 - Distributed collections to the city that should have been distributed to the county when the arrests were made by either the CHP outside of city limits or the sheriff. Occurred because citations were incorrectly entered as city arrests instead of as county arrests.



Systemic revenue distribution issues found on **recent audits:**

- Distribution as a city arrest even though arresting agency was county sheriff
- Distribution of \$1 to Local Courthouse Construction Fund from TVS fee even though county transferred all court facilities and no associated bond indebtedness remains
- Uploaded incorrect \$10 base fine into system instead of \$25 base fine required by statute for violators who subsequently provided proof of valid fishing license at the time of citation
- Used distribution percentages that are inconsistent with percentages required by statute for Proof of Correction cases
